Are You 12 or Under?

It has come to our attention that unsupervised play on the sports courts has led to increased dames to the sports courts such as, damage to tennis and volleyball nets, parts of the court flooring being removed, littering, and use wheeled vehicles on the courts.

The Board has decided All children aged 12 and under must be always accompanied by an adult (18 years or older) while at the sports courts.

Violations of this policy may result in suspension of ALL common area privileges. Please report any incidents to the office. Thank you for your cooperation, and landlords, be sure to share this and any new policies with your tenants!

For the safety and comfort of all members of our community, dogs must remain on a leash at all times while outside. Off-leash pets have led to disturbances and potential safety concerns. If you observe any violations, we encourage you to



report them anonymously to the management office or contact Animal Control directly. Please note that violators are subject to fines.

Additionally, we kindly ask that no food be left outside for stray animals, as this can attract unwanted wildlife such as skunks and rodents.

Community Discussion

- The intersection of Summerfield and Herndon Parkway near entrance to Autumn Glen was discussed regarding cars running red lights, very dangerous situation. The board will schedule a meeting with the town later in the year to see what can be done. In the meantime, everyone was encouraged to use the 'Herndon On the Go' app to report abuses at this intersection.
- Recently there have been persons standing outside the pool area staring in at the pool. The situation did not feel safe. A recommendation was discussed to add landscaping near the entrance to prevent persons from peering in. Th next budget cycle will consider allocation of funds to add something to prevent this type of situation.
- Normally, there is excessive trash and firework debris all around the common area, but this year the area was exceptionally well cared for. Minimal trash was collected. Hopefully this trend will continue.

Operational News

- The lifeguards have the discretion to remove flotation devices if they feel they are unsafe due to the size of the device and/or if the pool is crowded. Please support the guards when they have to act for your safety.
- The board is pursuing purchasing toddler and infant swim vests that residents can borrow while at the pool. The vests will be clearly marked as property of Four Seasons and must remain on the premises..
- Shower heads in the bathrooms were replaced due to a leakage situation and some were very moldy.
- Inquiries will be made with air conditioning companies to determine if the main clubhouse area can be made cooler in the summer and warmer in the winter.
 Feedback/estimates will be shared once received.
- The dumpster in the parking lot has been replaced with a more accessible model.
- As done in the past, the office would like to coordinate a community yard sale in the fall or spring. We have done this in the past and was very successful. Look for more information on this in the following newsletters.
- The bench near the baseball fields is broken. Since the fields are no longer used by the Herndon Optimist, the bench will be removed for safety reasons. Also, the bleacher will be removed due to lack of use.
- Recently residents were advised that they could not dive in the 5ft area of the pool.
 This is incorrect. The lifeguards will be reminded that diving is allowed anywhere where is does not say 'No Diving'.

Good to Know!

- The deadline to correct you Architectural Control Committee (ACC) violations was July 15th. You will be receiving a letter advising you of charges being added to your account if you have not submitted pictures of the action you have taken to resolve the violations to the Four Seasons Office. If you have made corrections, and receive a letter, please contact the office so we can discuss waiving any charges assessed.

- (1) IMPORTANT!! <u>VISITORS PARKING</u> Exceeding 3-CONSECUTIVE Overnight parking in same space with same TH number ON HANGTAG (No matter what vehicle) will <u>be towed / No-Notice</u> Towing for vehicles non-compliant with Safety Inspection and/or Vehicle Registration shall be in effect after 30-days following the month of non-compliance/Parking in Areas that are Emergency Access Lanes YELLOW Curbs and Double Parking in these areas are subject to towing. NOTE THAT TOWING FOR THE THREE OFFENSES ADDRESSED ABOVE SHALL BE ENFORCED beginning AUGUST 1,\
