## Four Seasons Recreation Association Board of Directors Board Meeting Wednesday May 14<sup>th</sup>, 2025

#### **Community Discussion:**

- One of the meeting's guests talked about having one of the tennis courts converted to a pickleball court. He felt there is a strong desire among the community to have something like this. There was a discussion about the potential noise and complaints that might be received from the surrounding townhouses. The guest resident offered to do some research on the noise level considering the distance of the court to the townhomes. Four Seasons residents will be surveyed as they come into the office to see if they are interested in something like this. The Recreation Director will also reach out to our current vendor who maintains the court to see what the cost would be to replace a tennis court with pickleball. There are temporary courts that can be set up; the board is considering this to do a trial run to measure usage and noise complaints. We need to find out the cost of the temporary courts. Pickleball courts will be carried as an agenda topic for the next meeting.
- Walter let us know that the next Town Council Meeting will be in a different format. Residents will be able to intermingle with the town council and ask questions and have a dialogue about concerns. Everyone was encouraged to attend.

#### **Business Director (BD)**

- Tree outside the office window was trimmed to allow better access to cameras surveilling the parking area.
- We continue to have issues with shopping carts being left on Four Seasons property. The Herndon On the Go app is being used to report these incidents but lately that has been ineffective. Someone recommended contacting the grocery store that owns them to see if they will collect them; in their experience this has been very effective.
- The office will be investigating replacing our current billing and record management software with a more user friendly and efficient package. Our current system will be going out of support unless we update to the new version, which is very expensive.
- Ivonne suggested we update the Rental Agreement to include some new items; more to follow on this.

#### **Recreation Director (RD)**

- The Pool is on track to open May 24th
- New picnic tables are in place
- Two swim lanes will be used this year unless there are complaints.
- Recording of who attends the pool will be entered via a laptop at the entrance instead of a sign-in sheet; this will be used for capturing and maintaining record of who attends the pool.

#### **New Business:**

- New Board Member Merlin Aguilar expressed interest at our last meeting in joining the board and after introducing herself, the board approved her to fill the Single Family Vacancy we have on the board. Welcome Aboard Merlin!
- Architectural Control Committee review of the community began May 6th and should wrap up May 16th. To date, we cited over 120 homes with issues ranging from not storing trash/recycle bins out of sight to rotting dormer trims and siding that needs to be cleaned or repaired. Letters will go out by the end of May.
- There are a group of homes who have ignored the Architectural Control Committee's findings on the condition of their home from the last cycle and previous review cycles. They will receive a special letter encouraging them to comply. The goal of the Committee is not to make money off of the maintenance issues, but to encourage homeowners to care for their home's appearance.
- The entrance to the pool is lined with Trash/Recycle Cans. The Recreation Director is determining how we can mitigate this to make the entrance more attractive.
