

FSHOA Parking Policy Update

The Board of Directors has approved changes to the Expired Tags and Inspection Policy, which will go into effect on September 1, 2025. Details will be shared via U.S. Mail (included with the Annual Meeting and Budget packet), TownSQ, social media platforms, and fallout newsletter

Any vehicle with expired inspection stickers or license plates will be subject to towing without notice 30 days after the expiration date. Ex. If

your inspection or registration expires on 08/25/25, the vehicle will be eligible for towing on 10/01/25.

Community Discussion

The board expressed concerns about a home based business (HBB) in our neighborhood, specifically the hours of operation, number of vehicles, and maintenance of the home. The board wants to stress that all local and county regulations must be followed, and the Architectural Control Committee (ACC) will be on the watch for violations and will pursue charging the resident for failure to comply and potentially legal action. The board supports HBBs in Four Seasons but not the detriment of property values and safety of the community.

Operational News

- National Night Out (NNO) was a great success; over 140 people attended. The
 office is going to reach out to the police and see if they can come earlier next year.
 Many of the children did not get a chance to meet the police due to their late
 arrival. Many thanks to Barby, Ivonne and all that participated in making this event
- Sports Court Basketball hoop is being repaired by our vendor. The hoop can be raised and lowered, and some residents are abusing the equipment by sitting on the hoop. We are looking at ways to remediate this problem with the vendor. The hoop can be lowered to accommodate handicapped people and children who want to enjoy the facility. Those residents who abuse the equipment are doing disservice to the community.
- The She Believe in Me organization organized a backpack collection and distribution event at the clubhouse. Over 300 backpacks were given out. Special thanks to Debra Hagen and Al Pham for making generous donations to the program as well as to the office staff who helped make it happen.
- Pool rule enforcement has been inconsistent this year with the current lifeguard staff. Next year a meeting will be held with the Pool Management company, the head life guards and members of the Board to ensure everyone knows Four Seasons Pool Rules.
- Yard Sale is planned for 9/27; so far approximately 15 people have signed up.
- The lifeguards can now accept credit card payments at the pool entrance for guest passes.

Four Seasons Homeowners Association Board of Directors Monday, August 11th, 2025 Overall Meeting Summary, Announcements, Reminders:

Fallout Notes FOCUS: 1) Community awareness, and 2) Business Conducted COMMUNITY AWARENESS INTEREST ITEMS

- (1) IMPORTANT!! For your own benefit and safety, please ensure you are following the enhanced and modified parking enforcement rules in accordance with changes made to our FSHOA Parking Resolution and as addressed in last month's Four Seasons Fallout Newsletter!
- (2) FSHOA now requires supervision by an Adult 18-years of age or older at the HOA Playgrounds whenever anyone is present 12-years of age or younger (see Vote 1 below). Matches Four Seasons Recreation Association implementation of Adult supervision required at the courts and Rec playgrounds.
- (3) HOA Annual Meeting Date is established as October 13, 2025 at 7:30 PM. Please make your plans to participate.
- (4) 2026 FSHOA Budget was presented to the Board for review. Note that traditional dues increase in alignment with Consumer Price Index (CPI) of 2.2% this year, means an increase of approximately \$4 per quarter for FSHOA Owners.
- (5) OPEN FORUM: a) NATIONAL NIGHT OUT: Barby noted that at the August 5, 2025 event, residents—especially children—waited a long time for the police, who arrived near dark after many had left. The Rec Association and HOA will address this with the police and request higher priority for our community in the 2026 event.
- (6) FSHOA Community Meetings: Our next Community Monthly Meeting is Sep 8, 2025 at 7:30PM. Our new start time seems to be working out well, but we would love to see more community attendance. Remember we need 4 more Board Members too! Please participate and join us! COVID-19 vaccinations required, and masks encouraged. In-person meetings at clubhouse continue, with Remote/virtual attendance upon request at least 24 hours in advance.
- (7) Do your part for **SAFETY:** Contact Herndon Police: <u>EMERGENCIES</u> call 911. <u>Non-Emergency, Suspicious Activity</u>, and <u>other concerns</u> - call HPD (703) 435-6846

MONTHLY MEETING BUSINESS CONDUCTED

- Meeting focused primarily on presentation of the 2026 Proposed Budget and Financials, as well as Management highlighting the following: ACC Inspection progress/status/extensions; FSHOA Taxes; upcoming Mgt/FSHOA contract renegotiation (Aug 13, 2025); Premier progress with hazardous/loose branches/limbs; AND OF NOTE: Successful engagement with Dominion Power POC who had finally repaired a yearlong lighting issue at another HOA community and all indications is they will also finally repair our yearslong lighting outages. Board will continue to monitor this closely as a safety/welfare issue.
- 2) FINANCE/BUDGET 2026 FSHOA Budget Build presented. Current 2025 Budget doing well over-budget on Admin but under-budget on everything else. Following in-depth 2026 Budget Report by Jason, community can expect the following: raise in FSHOA Annual Dues matching CPI of 2.2% (will need to be voted upon once actual CPI determined); attempt to stop sending Annual Dues Coupon Booklets to anyone paying their dues digitally (currently only those paying through Associa Legum and Norman do not, but those paying via TownSquare still receive the booklets at a hefty mailing expense); increase 2026 Capital Reserve Contributions from \$65K to \$75K (increase based on Annual Interest Earnings and additional underbudget amounts available) (Capital Reserve Accounts are used to pay for improvements/repairs to all FSHOA Common Areas Parking, Sidewalks, Grounds, Erosion, etc.).
- 3) VOTES: VOTE 1) Board voted unanimously to mirror Four Seasons Recreation Association Adult Supervision Policy at their ball courts, fields, and playgrounds. HOA Playgrounds Effective Immediately, Supervision by an Adult 18-years of age or older shall be required on the FSHOA Playgrounds for anyone present 12-years of age or younger.
